1. Description

AIP, AIP Amendments, AIP Supplements and AICs will be provided as Electronic documents and are available on the AASL website: www.airport.lk in downloadable form. Access to eAIP on the AASL website is free of charge and no user login or subscription is required. This is to inform that these publications can also be obtained in CDs by subscription, priced at US\$ 40 per annum and are subjected to the postal service fees. Printed publications, however, are still provided but only upon request and will be charged US\$ 40 for initial subscription, followed by US\$ 35 for annual subscription subject to the postal service fees.
