<u>Limitations to ongoing aircraft operations at Bandaranaike International Airport Colombo (VCBI)</u>

(AIP Supplement 11/23 is revised)

1. Introduction

- 1.1 The purpose of this AIP Supplement is to inform all aircraft operators about the limitations to ongoing aircraft operations due to construction work of new Terminal Building (T2) and associated new Pier Buildings at Bandaranaike International Airport Colombo.
- 1.2 The "Parking Stands Availability & Refueling Schedule", which was published by AIP Supplement 11/23-Appendix C is revised due to improvement of existing parking arrangements.
- 1.3 TWY E1 limitation, which was notified by NOTAM A0691/23 is incorporated to this AIP Supplement.

2. Limitations to ongoing aircraft operations

- 2.1. TWY E1 available only for aircraft taxi out operations.
- 2.2. Airside ground handling services are expected to delay due to the following airside rearrangements:
 - Revised shifted parking stand locations in Apron B and Apron C (Refer Appendix A)
 - Shifted service roads around Apron B and Apron C (Refer Appendix B).

3. Parking stands availability and refueling schedule


- 3.1 Availability of parking stands in Apron B and Apron C will be limited as mentioned in Appendix C.
- 3.2 Due to the shifting of parking stands, hydrant refueling system in Apron B and Apron C will be affected. The limitations therein are stated in Appendix C.
- 3.3 The refueling limitations for B15-B18 and C19-C26 where hydrant refueling will not be available shall prevail until the completion of the Terminal 2 project.




- 4.1 NOTAM A0689/23 and A0691/23 are hereby superseded and refer the NOTAM for further updates.
- 4.2 AIP Supplement 11/23 is hereby superseded and AIP Supplement 01/24 remains current until cancellation notified by a NOTAM.




Shifted parking stands locations in Apron B and Apron C














