POST OF AIRCRAFT TECHNICIAN

Job Scope : Responsible to deliver Aircraft Maintenance services to support the operational requirements as directed by the customer airline supervision (On board Engineer) and will ensure all maintenance and related activities are performed in accordance with the Airport & Aviation Services (Sri Lanka) (Private) Limited/customer airline procedures and supplied aircraft maintenance data.

Key Responsibilities :

- i Every aircraft gate and aircraft hard standing position must receive a foreign object debris inspection "FOD Walk" prior to every flight arrival and again prior to each departure.
- ii Performing Marshaling to guide pilots to turn, slow, down, stop and shut down engines, leading the aircraft to its parking stand or runway.
- iii Refueling the aircraft with specific fuel according to company procedures and customer airline guidelines in order to enable the aircraft to continue its journey.
- iv Using headset to communication without the need to hold a separate communication device, freeing up their hands to work on specific tasks. This enables technician to perform maintenance procedures efficiently and safely without interruptions.
- v Performing pre-flight and post flight inspections as per specified schedules and procedures to ensure the aircraft is airworthy and ready for flight. This may involve checking control surfaces, fluid, levels, tires, brakes, and other critical components.
- vi Identifying and resolving technical issues or malfunctions in the aircraft systems, engines, avionics, and other components during line maintenance activities. This includes diagnosing problems, replacing or repairing faulty parts, and conducting functional tests under the supervision of customer airlines ground engineer.

- vii Ensuing compliance with applicable aviation regulations, guidelines and safety standards during all, maintenance activities. This include following manufacturer manuals, maintenance practices, and any relevant airworthiness directives.
- viii Adhering to safety protocols and procedures to ensure personal safety as well as the safety of aircraft, crew, and passengers. This entails following lockout/tag out procedures, using protective equipment, following electrical safety measures, and actively participating in safety programs.
- xi Maintaining effective communication with other maintenance findings, coordinate repairs, and ensure clarity regarding aircraft readiness.
- x Keeping up to-date with advancements in aircraft technologies, maintenance practices, and regulatory changes through training and professional development. Staying current is vital to ensure proficient and safe performance in this ever-evolving field.
- xi Overall, Aircraft technicians are responsible for ensuring that aircraft are properly maintained, safe to operate, and in compliance with regulations to support safe and flight operations.
- xii In addition to the above key responsibilities of the Aircraft technician, responsible to attend any other relevant responsibilities assign by the Head of the Division or an authorized officer.

1. **Qualification :** i Should have Passed the GCE (O/L) Examination

- ii Should have a relevant vocational, tertiary or trade qualification from a recognized Aeronautical College.
2. **Experience :** Should possess Five (05) years' experience within the Commercial Air Transport Line maintenance operation on modern Jet Aircraft.
3. **Age :** Age should be below 45 years at the closing date of applications.
4. **Salary :** The selectees will receive an attractive remuneration. In addition to that, the selectees will receive attractive fringe benefits.
